


Norfolk Anglers Club - Redfish "Spots" Tournament

Fishing Reports...



31 July: I fished with the Evans family out of Lynnhaven Inlet and started trolling Clark spoons parallel to the Chesapeake Bay Bridge Tunnel (CBBT). Fishing was slow as we caught one Spanish Mackerel and one Bluefish. We fished until the end of the ebb tide and began catching Spot and Croaker using Squid FishBites.

We used a couple of the Croaker for bait on the CBBT Second island to see if any Drum would be coming through. No Drum but the Skates kept the crew busy. Overcast conditions never allowed us to sight fish so we went back to trolling spoons and finished the trip with a few more Spanish Mackerel being caught.

1 August: The Cottingham family and I fished the ocean front out of Rudee Inlet heading South in 30 foot of water. Spanish Mackerel started biting slowly on spoons as the North current pushed cleaner water into the area. Off of Sandbridge, I sight casted a bucktail jig at two Cobia, one at 46 inches and another at 38 inches. We kept the 46 inch fish and released the other. -- Alex Perez

3 August: Early Morning at Little Creek; Louis Glaser and I have been going out fishing at Little Creek at sunup fishing a few hours for two weeks just to beat the heat, that has been making fishing a miserable experience this summer. Most of the time we have been skunked but over the last week the spot have been bigger and we've stumbled on a school of nice speckled trout in the 14-15 inch range and an occasional puppy drum. But this morning, I finally got some puppy drums!

On my first cast I hooked up what seemed like a big red drum, with line pulling even with my drag set tight. The fish came to the surface at one point and we could see it was a puppy but it was too far away to get a sense of size. But the fight took a while with it pulling drag despite my gaining line at each run. Finally when I got it to the boat, we found it was two puppies one hooked on the tail hook and one on the front hook of my 27MR MirrOlure (see netted pups). WOW!! I've never had that happen before. Both were 21 inches long and about 3.5 lbs. each. So once I got them in the live well, I casted at the same place and hooked two more puppies the same size. Then Louis started catching speckled trout on a 52MR. Likewise, I also started bringing in trout. The reds were no more for the day. We ended up catching about 15 speckled trout, 8 of which were 15-16 inch keepers and were off the water by 8:45 AM. - Dr. James W. Ike Eisenhower

15 August: At daybreak, I again went fishing with Louis Glaser. Using topwater lures I caught a 21.5" speckled trout which made it a club minimum as I released it. We caught two more keepers and several throwbacks until after about an hour of raining hard on us, we called it a day.

16 August: We fished the same place, same time as the days before and caught 14 keeper speckled trout with Louis catching the biggest one 21.5 inch. The big one hit the first cast with a topwater Spook Jr. Could not find any reds but not complaining since the action with MirrOlures was so active. Louis caught 5 on topwater lures whereas mine were mostly caught on 17MR's. - Dr. James W. Ike Eisenhower



10 August: It was a very early Monday morning when Ned, Bert Sainz and I headed to the CBBT to fish for flounder. The guys usually take me along for luck and Bert was the first to feel the luck. He caught a good-sized flounder (Ned will share the statistics) and then another. In the meantime, Ned and I got nothing but nibbles. Finally, a whopper clamped on to my hook. After 10 minutes or so of fighting this guy, I pulled up a 4 foot eel. He was huge and it took a lot of work for the guys to get him off the hook and back into the water. I was convinced it was a Moray Eel but the guys convinced me he was American.....you could have fooled me he was a monster!!!



Ned and I finally began to catch. Mine was a pretty big one...they said around 23 inches. In total we had 6 nice flounder in the box. We used live and cut bait. Got back to the dock around 1:30 pm and cleaned the fish and the boat. It felt great to be out on the water. Thank you Bert for the ride.

10 August: John Curry and I sight fished for Cobia with my nephew Christian and his brother. Christian has a new 26 foot Boston Whaler Outradge with twin Suzuki 225 and a tower, what a great set up. We fished from the CY buoy north to the town of Cape Charles and saw plenty of Cobia, I lost count at 12.

Most of the fish were smaller but there were a couple of good size ones. Unfortunately the cobia were being very finicky, possibly because of all the boat traffic from other sight fisherman.


Although most of the fish we cast to would chase our jigs or eel only one came tight. John landed our only fish which measures 38/39" and went back.

9 August: I went with Billy Ragulsky and Ted Crumb to fish a couple of local wrecks. We left Rudee Inlet and headed to the Gulf Hustler and Brass Spike wrecks. We arrived at the Gulf Hustler first and made a couple of drifts over the wreck for Flounder. Flounder never bit but Billy caught a decent Black Sea Bass so we decided to anchor on the wreck. Using diamond and flutter jigs with Squid, we started catching more Black Sea Bass along with Scup, Ribbon fish, Bluefish, and Skates. While on anchor, a school of smaller Mahi swam through. We ended up catching three of the Mahi and released the smallest fish of the three. On our way to try the second wreck, we saw a large school of False Albacore that wouldn't bite. On the Brass Spike, we caught a few more Black Sea Bass with only a couple being of legal size. We passed a buoy on the way in which had a 30 inch Cobia that ate a

bucktail jig. - Alex Perez

25 Aug: Alex Perez and I headed out to Rudee Inlet in the afternoon for a few hours of fishing in the Carolina Skiff. We fishing for about 4 hours trying the oyster bed in the middle of Lake Rudee, the Bridge, and a couple of places in Lake Wesley. We had a number of "hits" and signs small bluefish were around (ate the tails off the gulp mullet). Water temps were a bit warm at 82 degrees.

For the last hour we headed to the creek behind the Aquarium and fished a feeder creek and the drain channels on a falling tide. Alex landed a couple Puppy Drum on a jig-head with a gulp tail.

9 Aug: Headed out of JEB Little Creek/Ft Story before sunrise to pick lke up at MorningStar Marina. The news from fellow Norfolk Anglers had the Speckled Trout and Puppy Drum bite was pretty good but the water temperature was steadily rising.

We fished the edge of the rocks and some of the grass beds with MirrOlures (17/27MR) and jig-heads with gulp tails. Most of our succes came from the jig-heads and around the rocks. We caught and released a few Puppy Drum, Speckled Trout, and Flounders. All our fish were tagged and released for the Virginia Game Fish Tagging Program

14 August: I fished with Louis and Jack Spollen from sun up till 9:00 am. While fishing with Hadden Spook Jr topwater lures, we caught four keeper puppy drum and four keeper size speckled trout. It's a blast watching those fish hit your lure on the surface. One of mine had five spots on one side. I tried to take a good picture but he didn't want to stay on the measuring tape.



But at least you can see the spots, he was over 19.5 inches long. Watching these reds and specks hitting a topwater lure and even missing the lure a couple of time before finally hooking up is a great visual fishing experience. Of course, the reds really take off once they realize they are hooked. This is another entry into the Norfolk Anglers Club red drum spot contest. Non-offset, non-stainless circle hooks required for Recreational Striped Bass fishing with bait:



July 28th Commission Meeting: Proposal to amend Chapter 4 VAC 20-252-10 et seq., "Pertaining to the Taking of Striped Bass" to require the use of non-offset, non-stainless steel circle hooks when fishing for striped bass recreationally with bait, to



clarify that the captain or operator of any recreational boat or vessel shall be responsible for any minimum or maximum size limits, and to repeal section 4VAC 20-252-115 Exemptions

from size limits and closed fishing seasons for recreational striped bass fishing tournaments. The Commission voted unanimously to approve amendments to require the use of non-offset, non-stainless steel circle hooks when fishing for Striped Bass recreationally with bait, to clarify that the Captain or Operator of any recreational boat or vessel shall be responsible for any minimum or maximum size limits, and to repeal Section 4VAC 20-252-115 Exemptions from size limits and closed fishing seasons for recreational striped Bass fishing tournaments.

Federal Permitting & Reporting required for all recreational tilefish trips



Beginning August 17, 2020, NOAA Fisheries will require private recreational tilefish vessels, fishing north of the North Carolina/Virginia border, to have a federal recreational tilefish vessel permit and file catch reports. These changes were approved

in Amendment 6 to the Tilefish Fishery Management Plan. This action is being taken to better characterize and monitor the recreational fisheries for both blueline tilefish and golden tilefish.

Apply for your federal private recreational tilefish vessel permit through the NOAA Fish Online website (https://www.greateratlantic.fisheries.noaa.gov/apps/login/login). You must apply for this permit using our online system, we are not providing paper applications for this permit. This new permit is required even if a vessel already holds a for-hire tilefish permit.

Private recreational tilefish anglers must also fill out and submit an electronic vessel trip report within 24 hours of returning to port for trips where tilefish were targeted and/or retained. Reports can be submitted through any NOAA Fisheries approved electronic reporting system. See the NOAA website for information on electronic reporting options at (https://www.fisheries.noaa.gov/new-england-mid-atlantic/resources-fishing/vessel-trip-reporting-greater-atlantic-region)

Reminder: Cobia Permit Holders, report your harvest or lack of participation in the Cobia season



If you have not had an opportunity to take a trip or report a trip, this is just a reminder of the reporting requirements of the Recreational Cobia Permit. There is plenty of time to submit a trip report either with or without cobia harvest OR to report your lack of participation in the 2020 cobia season before the October 21, 2020 deadline. The reporting requirement for this permit can be found in regulation Chapter 4 VAC 20-510-10 et seq., "Pertaining to Amberjack and Cobia" (https://www.mrc.virginia.gov/regulations/fr510.shtm).

VMRC will accept reports only by form (https://www.mrc.virginia.gov/Forms/) or through the Virginia Saltwater Journal. VMRC will not accept any reports by phone. If you submit a report on the Virginia Saltwater Journal, you will receive an auto-generated confirmation email of the report that we encourage you to keep for your records. If you have technical issues submitting reports on the Virginia Saltwater Journal, please call VMRC staff for assistance before the reporting deadline.

If you hold a 2020 Recreational Cobia Permit, you MUST report by the deadline. If you do not report by the deadline of October 21, 2020, you will NOT be eligible for a Recreational Cobia Permit in 2021. Your ineligibility will expire in 2022. There are no exceptions.
